# TOWN OF CRAFTSBURY REGULAR SELECT BOARD MEETING

- Action Approve of Minutes:

Bruce and Jim decided to wait until next week to vote on the Dec. 21 minutes.

Discussion - Albany Recycling, Philip Beaudry:

Philip explained that the Albany Recycling has been getting a large influx of residents from Craftsbury. Right now, Albany residents are footing the bill for the recycling section, since Albany offers free recycling for their residents; built into their taxes. Albany residents pay just for trash and tires. Phillip gave the Select Board the annual cost, based on their Northeast Kingdom Waste District per capita fees for their town. Right now, the district handles all their permits, etc. Albany splits 50 50 with Irasburg. If we join, that fee would be 1/3 of the costs instead of the 50 50.

Penelope mentioned that although Craftsbury charges for their recycling, residents didn't have to sort it. In addition, Craftsbury doesn't pay labor to run it like Albany. She explained the separate districts was done a long time ago, not necessarily by the county. They discussed cardboard recycling costs, district fees.

Phillip said many residents on Town Line Road has been using the Albany Recycling facility for years, but it's getting more and more.

Penelope said that Craftsbury doesn't advertise Albany Recyling as an option. She's been advertising All Metals and Wolcott. She also been posting every week on FPF whether open or closed. If Craftsbury runs their own Recycling Center in the future, Penelope said there are a few local people interested in the job.

She remarked that for some people, bring trash and recycling to Albany wouldn't be as cost effective. Penelope said she keeps going back to the carbon footprint of going to Albany, wonder if there is a middle ground.

Penelope said that Morrisville is in the same situation as us, can't leave trash overnight. Right now it goes from Stowe to Morrisville then to Craftsbury, but needs 2 people. Phillip said right now, Albany is looking for an attendant and that he is filling in for now.

Penelope said she can remind Craftsbury residents that Albany's residents are paying for the recycling. She mentioned in order to change Craftsbury's district, would take some time, need to be voted on, lawyers too.

Bruce suggested to have Albany charge Craftsbury residents or refuse Craftsbury residents if that's not possible.

Penelope suggested sending our prices to Albany's Town Clerk, Jim agreed. Jim said to wait until Albany decides before proceeding. Penelope will wait until Craftsbury hears back from Phillip to send out a notice to Craftsbury residents as well. Jim thanked Albany for helping out Craftsbury.

They discussed having the next bulky day, maybe the 3<sup>rd</sup> Saturday in June.

Cheryl suggested having one account for infrastructure and equipment, for the FEMA 19 funds and bridge funds; Jim and Bruce agreed.
