MINUTES: Diane moved to approve the revised minutes circulated by June on June 21; Elinor seconded the motion. In discussion, several amendments were made: page 2, paragraph 1, change "She" to "Steve"; page 2, paragraph 1, change "needs to" to "must"; page 2, paragraph 2, change "Hardware cloth" to "Some hardware cloth"; page 2, paragraph 2, change "mow flat area" to "weed whack around plantings". - Conservation Fund Promotion and Growth: led by Steve, staffed by Diane and Farley
- Educational Outreach: led by Ashley, staffed by June, Heidi
- Invasive and Non-native Species Control: led by Elinor, staffed by Diane, Steve, Brian
- Natural Heritage Inventory: led by Farley, staffed by Brian

Steve tasked each Working Group to present its 2021 goals at the next meeting.

STEVE WRIGHT MEMORIAL BENCH: Select Board and Village Improvement Society decided to anchor the bench outside the fence, to the west of the large maple tree near the southeast corner of the Common. Farley will seek a convenient date from the Wright family for a dedication ceremony. The plaque was stored in the Conservation Commission drawer at Town Hall. It will be secured to the bench with locking screws at the dedication ceremony.
