TUESDAY, SEPTEMBER 5, 2023 7PM | CRAFTSBURY TOWN HALL

Meeting Agenda

Jim Jones called the meeting to order at 7:02 pm.

- Action Adjustments / Changes to Agenda No changes.
- Action Approve Select Board Regular Meeting Minutes of August 22, 2023; Special Select Board Meeting Minutes of August 25, 2023

Bruce Urie motioned to approve the August 22 meeting minutes; Susan Houston seconded it. No more discussion. **All ayed. Motion passed.**

Susan motioned to approve the August 25 Special Select Board Meeting Minutes; Jim seconded it. Discussion re: Bruce Urie in grant administrator position: allows for FEMA reimbursement for administrative services. Payment only for FEMA contract work; will cost the Town nothing. For future consideration: Town to mull addition of a line-item for the grant administrator position in its 2024 budget. No further discussion. Bruce abstained from the vote. All ayed. Motion passed.

- Discussion Serin Decherd | "Children at Play" or "Hidden Driveway" Signage
 Building a house on hill on North Craftsbury Road. Electrician was almost t-boned by someone
 racing up hill; waiting for bus have witnessed speedy vehicles. New house. New driveway.
 What's the process for obtaining *Hidden Driveway* sign? One facing drivers headed down the
 hill. *Children at Play* signage no longer legal for municipalities. Cannot appear to be a town sign;
 liability issue. Two-to-four weeks for delivery of sign; no cost to homeowner. Mirrors (multidirectional): are those allowed? Yes. No need to coordinate with town. Cost to Town for
 signage: \$75-\$100 per sign/based on letter count.
- Discussion Town Garage Update

State has only one bridge left; Craftsbury rejected for temp/movable bridge. Makes Town eligible for FEMA funding; have three RFPs to start process. Discussion: don't want to send snowmobilers and skiiers through pedestrian area; will post not for trucks. Town working on tentative plans. Write RFPs; all won't happen this year; get engineers to start looking at it – how to repair and make bridge accessible on both sides (fill in/repair cracks in walls). Hoping by this week to send out RFPs.

• Discussion – Update on Energy Committee Activities Including Grant Request |Kevin Gregoire Activity Update – report submitted.

- Firewood Program college assisted with firewood program for a full day. Have 17
 recipients of firewood this year; will have probably six or seven cords of split wood
 stored over the winter for those who will need it.
 - Potential Structure of Program for Sustainability: an unknown. Spoken with other programs; some have hired person. United Way and in Maine – in an affluent town – someone to do logistics. Some programs run by local churches using all volunteers; structured programs have hired workers. Sterling College and Outdoor Center provides good volunteer sources along with the general public. Parks and Rec providing wood to group programs.
- Window Insert Program end of October workshop: build 230 or more inserts at workshop. Dates: Oct 23 (Monday) through Tuesday (Oct 31) .
- Grant Request proceeds would allow for purchase of two-four log splitters (as much as \$15K application limit). Having log splitters of our own would be an incredibly useful tool; no need to beg-borrow-steal for last-minute efforts. Those people who cannot receive on a delivery day can split their own. Can be stored in local barn / on other property covered by tarp, out of sight. Requires proof of liability insurance for program; what does Town liability insurance cover for Firewood Program (will need to contact adjuster; Bruce to contact and get back with Kevin). Another grant: \$4K (\$3800 towards income challenged people who need inserts). \$4K grant can be spent on education / outreach; also look toward adding to savings fund for unforeseen costs. Something not covered by main grant. Encouraged to collaborate with other towns: potentially with Greensboro (weatherizing library).
- Solar Project at Library battery lost warranty due to flooding. Donors came forward and purchased battery; 36K of storage; now stored on higher ground; electrical vehicle charger at library potential: seeking grant; potential for heat pump.
- Municipal Energy Resilience Program weatherizing town buildings; lots of info and tracking; good progress on this.

QUESTION: Ash Tree removals? Any new movement? No. Follow up: Thermostat?

- **Discussion Lamoille Kennels Is No Longer Taking Stray Dogs** Alternate place in Newport; has other location options.
- Discussion Update on Dog Concern | Two Dogs Beagle and Black Lab found; dog warden picked up. They were Wolcott dogs; they were very tired. Picked up by Wolcott warden.
- Discussion Grader Expected August. 29th; Payment Due in a Week Not here yet. Payment not made yet. Discussion.
- Discussion Signed Use of Common Form Rural Arts Oct. 7th It's all signed. (8 am to 5 pm)
- **Discussion ACLU Letter** Letter received from ACLU re: homeless / sheltering on public lands.

• Discussion – Antiques & Uniques Disbursements

Work ongoing on balancing receipts/disbursements. Discussion. Net profit: \$1796; \$15/hour payment = \$2221. Remove \$400+ from backup account (\$5K). Action – Bruce moved to pay the \$15 to payouts; Jim seconded the motion. No further discussion. All ayed. Motion passed.
