We will need to work on grants such as VEC, AAA and VT Tourism soon, keep on agenda for next meeting. We should also look into public radio sponsorship.

7. Review & approve Town Report text

We made minor changes to the Town Report draft. Michelle will correct and send to the auditors.

8. Site Plan review

Bruce has emails out to 3 different electricians. Is hoping to hear back from at least one of them in the next few weeks.

9. Food & Beverage vendors

Bruce will check in with the Urie's about being a food vendor. Lise has talked with Kingdom Kreperie who is interested in becoming a food vendor. Michelle had spoken to Front Seat Coffee, C Village, Wood Belly

Pizza and The Farmer and the Spud, who all were happy with A & U last year.

10. Recruit volunteers & coordinators

We will work on at a future meeting.

11. <u>Timeline & Next Steps</u>

We decided to look into having a conversation about a music fundraiser Sunday night with a couple food and alcohol vendors. We would pay for the music and food/alcohol vendors would pay plus attendees (donation jar). We will need to let the Village Improvement know as soon as we decide.

We also talked about selling some swag, such as A & U tshirts and bags. Will need to look into design and supply pricing.
