Agenda reviewed (Alan)

Updates: Lise emailed Kevin Gregoire and Louise Calderwood re: ARPA committee. Since neither have been available to participate, their names are removed, but they are encouraged to follow on the town webpage.

- Alan reported that his meeting with the Select Board was well received. The SB was clear in wanting ARPA group to review all proposals and send a slate to the SB for final consideration. Alan also notes that the SB may sequester \$32-\$35,000 for a generator for the Academy. Note: the ARPA group believes that the SB should attend the Pitch Session(s).
- Post Card (PC) Project: (Gina) A mockup of the proposed post card was shared. Before it can be mailed, application details need to be on the ARPA website with a link on the PC to the application. Gina worked with Michelle Warren to set up an email site to be used for incoming questions and to sign up for future information.
- Craftsbury ARPA Application: (Lise) Lise shared her draft of a grant application. Discussed and group concluded to give the application draft to Heidi, Gina and Phil to revise at a subcommittee meeting (set for June 17) and then share by email with group.

Overall Scheme: (Alan) A To Do List was developed in a kind of "What" "When" format which generated much discussion.
