## Approval Select Board Minutes:

## Hardwick Rescue:

The Selectboard met with members of the Fire Department (Walt Gutzmann, Steve Perkins, Cori Sanders, Jeremiah McCann, Randi Calderwood and Eric Britton) and also members of Hardwick Rescue (Mary Hall, Deb Larose and Ray Belavance) to discuss the process of getting more first responders in Craftsbury. Currently, Steve Perkins is the only first responder. Hardwick Rescue mentioned a new class will be available soon. They discussed the changes in Vermont regulations that required many more hours to maintain first responder status than previously.

## FEMA:

FEMA extension paperwork was submitted for the Cemetery Road with completion planned in 2013.

## Community Sign:

Harry Miller had requested permission for the school to build a community sign across from the school on the Common, outside of the fence. **Susan made a motion to allow the Academy to put a sign on the town property, Jim seconded, approved.** They will talk to Harry about the project.

## Red Cross Training:

The Selectboard discussed the Red Cross training scheduled Feb. 28<sup>th</sup>.

Weight Permits:

A weight permit was signed for Gould Well Drilling, Inc.
