Elect Chair for Board:

Susan made a motion to elect Bruce Urie as Selectboard Chair, Jim seconded. Motion unanimous, passed.

The Selectboard met at the Craftsbury Town Hall on Tuesday, March 10, 2015 at 7 PM. Selectboard present were Bruce Urie, Susan Houston and Jim Jones. Yvette Brown (Town Clerk), Michelle Warren (Clerk of Selectboard), June Cook (Hardwick Gazette) and Jim Flint were also present.

Approve Minutes:

Susan made a motion to approve the February 10, 2015 minutes as printed, seconded and moved.

Jim Flint, Town Meeting Rap Up:

Jim Flint came in and explained why he had asked for a motion to Article 6. His wording was slightly different than the moderator had said, he used designate instead of direct, and weatherization to efficiency, a little sterner than the original motion. Yvette said the minutes were correct however. Bruce said we were all trying to come to the same thing, weatherization for the school. Since the details weren't ready when the Town Report was being published, they had put a more generalized article in there, and had asked Steve Moffatt, School Board Chair, to explain the motion at Town Meeting. Jim Jones noted that although the town projects funded by the Good Neighbor fund have been energy projects, it could be for other town projects as well. It's the people's choice, the Selectboard can just direct the funds.

Susan said she contacted VLCT about possibility of combining warnings. She also suggested having committee chairs recognized at town meeting and talk briefly. There was concern about the extra time that would take at Town Meeting. Michelle suggested having photos of Town Committees put in the Town Report, or at least put on the website.

Susan asked how the Conservation Fund should ask for funding, for some of their projects. Bruce suggested putting on the forum for potential candidates for the Good Neighbor Fund for next year.

Weight Permits:

Jim made a motion to sign the following weight permits, seconded and moved.

The Selectboard signed weight permits for Gould Well Drilling, United Natural Foods. Inc., Scott Brown, Camp Precast Concrete Products Inc., Grimes Inc., Bournes Inc. Dale Percy and SD Ireland Concrete Construction.

Liquor Licenses:

Jim made a motion to sign liquor licenses for Craftsbury Sports Center and Craftsbury General Store, seconded, moved and signed.

Dispatch Center:

Bruce said legislature is trying to close dispatch centers in Derby and Rutland. On behalf of Craftsbury, Bruce will try and write a letter against closing Derby. Although it would be rerouted to Williston, service will probably be effected.

Jim Blair Signage Request:

Jim Blair sent email to Bruce requesting signage at the end of Collinsville Road sign in winter. Bruce said they just put one up in Eden though that said no thru traffic. They will wait to see how the Eden sign does this winter first but will talk to Steve about it.

Walk-ins that have business to come before the Selectboard:


