Parking Safety Issues:

Bruce said that people are parking at the corner of South Craftsbury Road/Creek Road, making it unsafe. Bruce will speak to the owner of the building at the corner.

"Conflict of Interest" Policy:

Bruce and Jim decided to wait to discuss the Conflict of Interest policy with Susan at the next meeting.

Road Foreman's report:

Bruce and Steve did meet with the Mellets and they are not interested in housing the invasive plants. They are considering the pit as a possible location for the mandated composing. Bruce asked the Mellets to bring their proposal

in writing.

Clerk Report:

Taxes are pulling in, both current and delinquent taxes. Yvette anticipates that in a few months she will need to send in the delinquent tax list to Angela Ross to start the process.

Battery Project:

Penelope updated the Selectboard on the outcome of the battery collection project. Between June 4 and August 23, Craftsbury citizens collected 103 batteries. The project will still continue, with drop off locations at the Academy, C Village Store, Library, and Town Hall. Michelle will repost on facebook.
